Nomination Process & Selection Criteria

CARE Centre's Joan Lesmond IEN of the Year Awards are presented each year to one member RN and one member RPN. The process for selection of the recipients for CARE Centre's Joan Lesmond IEN of Year Awards is as follows:

Nominator(s):

Any one of the following can submit a nomination individually or as a team:

- Self-Nomination by the internationally educated nurse (IEN)
- Nurse Manager and/or Administrator
- Team Leader, Clinical Educator or Preceptor
- Peers (nurses, health care discipline team members, physicians)
- Patients and Families
- Case Manager

If self-nominating, endorsements are required in the form of signatures from any of the following:

- Nurse Manager and/or Administrator
- Team Leader, Clinical Educator or Preceptor
- Peers (nurses, health care discipline team members, physicians)
- Patients and Families
- Case Manager

Criteria for Selection:

- 1. To be eligible for the award, the IEN who is being nominated has to:
 - be currently registered as a nurse in Ontario (RN or RPN)
 - be working in a nursing practice environment in Ontario for at least one year
 - be a member of CARE Centre for IENs.
- 2. The IEN being nominated consistently demonstrates professionalism in nursing practice as defined by the College of Nurses of Ontario (see appendix for reference)
- 3. Personal Story The IEN nominee will provide an essay on her/his personal story or experience. This essay should demonstrate the nominee's personal commitment to nursing. Their story will be assessed for indicators of courage, resilience and passion.

This story must be submitted with this application.

Review Process:

A panel of 4-6 individuals representing CARE Centre including the Executive Director, Board members, the previous year's award recipients and collaborators will review and recommend the selected winners to the CARE Centre's Board of Directors. Final selection of the award winners will be made by CARE Centre's Board of Directors.
